

Presbytery of the Peaks 116th Stated Meeting, May 3, 2018 Bulletin Insert

The One Hundred Sixteenth Meeting of the Presbytery of the Peaks was called to order by Moderator Dick Boswell at 9:30 a.m., on May 3, 2018 in the sanctuary of Quaker Memorial Presbyterian Church in Lynchburg, VA, who also opened with prayer. Pastor of the host church, Bart Edwards, offered a warm welcome to all. Customary appointments were made by the moderator.

The Stated Clerk presented the Docket and Consent Agenda. By common consent Rev. John Losee was granted the status of Honorably Retired as of May 1st, having served Unity Presbyterian Church of Danville for 14 years. For medical reasons, Rev. David Etheridge was granted Minister at Large status effective April 16th, having served St. Andrews Presbyterian Church, Lynchburg for 11 years. And Rev. Andy King was granted Minister at Large status effective May 11th, so that he may become a stay at home parent for his son and soon-to-beborn twin girls. The Docket was amended to include a verbal report by the Committee on Representation.

The Presbytery was led in worship by Ruling Elder Nikki Kariuki (Quaker Memorial), with Rev. Dr. Catherine Taylor (Pastor, Blacksburg) preaching, who was joined by Rev. Bart Edwards and Quaker Memorial elders in offering the sacrament of the Lord's Supper. Quaker Memorial Organist Rose Peak led the worshippers in music. An offering of \$760.52 was received for our Two Cents a Meal Hunger ministry, which was dedicated in prayer by Hunger Action Advocate Denise Pillow.

Following worship the Presbytery was led by the Mission Study Team in a discernment process that included small group Bible study and discussion of Chapter Three of the Book of Order as it pertains to the work of a presbytery. Divided into six groups throughout the church, members of the Mission Study Team summarized the feedback the presbytery gave in the February 2018 meeting. Six priorities were

then discussed in light of scripture and polity. The morning conversations ended with each commissioner indicating his or her convictions about priorities through a voting method designed by the team. (Results will be reported back to the August meeting of the Presbytery.). The Mission Study groups were dismissed with prayer to a delicious lunch arranged by Quaker Memorial.

Lunch was followed by announcements and concerns, which included a letter from the Session of First Presbyterian, Martinsville, asking the Presbytery to reconsider the schedule of the May meetings so that they do not conflict with the National Day of Prayer on the first Thursday of May.

For the second time in 2018, a new feature of the Presbytery meeting was presented, "Ministry Made Possible." High Bridge pastor Jason Grimes shared his congregation's experience as a Camp Peaks congregation, including the impact of the camp on the congregation and community. Then Rev. Allison Unroe, Moderator of Presbytery's Committee on Discipleship, presented all nine of the Camp Peaks 2018 host congregations, who were then commissioned for their upcoming work.

The Sexual Misconduct Policy Committee presented for a second reading a revised "Policy on Sexual Misconduct and Procedures for Misconduct Complaints." The revised policy was written to reflect the most current General Assembly guidelines and best practices. Additional materials were promised to guide Sessions in their work with such policies. The policy was approved.

The Committee on Preparation for Ministry reported its ongoing work and presented Rachel Sutphin, a member of Christiansburg PC, as an Inquirer in the ordination process, and shared her intention to enter Columbia Theological Seminary in the fall after successful graduation from Virginia Tech in May.

In response to a request by the Elon Evangelical Presbyterian Church, formerly of the PCUSA, the Trustees advised the presbytery to approve the release of the reversion clause on a 1 acre tract of land so that the congregation could make improvements on the remaining

property. It was approved, noting that the reversion clause will remain in effect for the church building and manse properties.

Allison Unroe, moderator of the Transitional Associate Presbyter for Discipleship Nominating Committee introduced Rev. Rachel Shepherd as the Committee's enthusiastic and unanimous choice to serve the presbytery in a transitional position. Rachel will be fulfilling the responsibilities of the Associate Presbyter for Discipleship for an initial two year term with a third year expected, while the presbytery continues to discern its vision and priorities.

As the Order of the Day, the Committee on Ministry's Moderator Sue Bentley led the presbytery in all the necessary business of examining and receiving two new Ministers of the Word and Sacrament: Rev. Chaplain Chad McCain, who will serve as Associate Pastor of First Presbyterian, Lynchburg beginning in July; and Rev. Rachel Shepherd, who began serving as presbytery staff in early April. Additionally, Tony Ward, a Commissioned Pastor and Moderator of the Commissioned Pastor Workgroup presented Margie Anderson for commissioning to service within the bounds of the Peaks as a Missional Commissioned Pastor, authorizing her to serve congregations as a preacher and worship leader, including sacraments, as congregational needs may require.

The Committee on Ministry recommended the formation of an administrative commission for Shelton Memorial PC, Danville, in response to their request to merge with another PCUSA congregation in Danville, or to be closed, pending the outcome of discernment led by the administrative commission. Presbytery approved the administrative commission and authorized the COM Moderator, Stated Clerk, and Transitional General Presbyter to appoint its members.

The Committee on Administration Report was given by Ed McElmurray, chair, who presented a Covenant Agreement to govern the relationship between the presbytery and Rachel Shepherd as Transitional Associate Presbyter for Discipleship. The terms of agreement were approved by the presbytery.

The Cabinet recommended on first reading a revision to the Manual of Operations that would make explicit the presbytery's responsibility and authority for deciding the location or relocation of the presbytery office upon a recommendation by the Committee on Administration. The revision was approved.

A brief Committee on Representation report was given by chair Rev. Joe McCutchen, offering a snapshot of our current status with regard to ethnic representation on presbytery committees.

Written reports were approved from the Committee on Discipleship, Session Records Workgroup, Presbyterian Women, Black Caucus, and Leadership, all of which may be found in the full minutes of the meeting which are online at the presbytery's website. Also in the full minutes are the presbytery's current financial reports. (www.peakspresbytery.org)

136 voting members were present. 36 non-voting visitors attended. 12 Ministers of the Word and Sacrament were excused, 12 were listed as absent, and 63 congregations were not represented by Ruling Elder commissioners.

After appropriate thanks were offered, the presbytery meeting was closed with prayer by Moderator Dick Boswell.
